## Background

REAL Women in Trucking (RWIT) was formed as a protest group in 2010 to combat the growing problem of censorship from other organizations that were essentially efforts to silence women who were coming forward with allegations of sexual assault and sexual harassment in major truck driver training fleets. In 2013, RWIT received their IRS determination letter recognizing the truck driver-led member supported organization as a 501 (c) (6) trade association.

REAL Drivers, REAL Issues. Since then we have made significant progress to create a platform for the voice of all truck drivers so they can be heard. We have been recognized internationally for our outspoken authentic advocacy related to gender-based violence and harassment in the workplace, wage theft, misclassification of workers, discrimination, lease purchase truck schemes, unsafe truck driver training and on national truck parking coalition workgroups. These have been the cornerstone issues of our focus when we speak to legislators, policy makers, communities and the media.

Recognition for Diverse Individuals. Beyond our advocacy work we were the 1st organization to ever present a dignified award to diverse individuals who work as truck drivers. The Queen of the Road and President's Choice Trucking Industry Trailblazer Awards were launched in 2017. Since then over 90 diverse truck drivers, including people of color and those who identify from the LGBTQAI+ community have been recognized as notable nominees and award recipients



# RWIT Initiatives & Achievements

RWIT has been a leader in raising the alarm on major safety issues related to commercial drivers license programs and gender-based violence in entry-level driver training fleets.

They have been the most active partner organization in the Jason's Law Safe Truck Parking movement that effected a bill to become a law and the subsequent **Federal Highway Administration Truck Parking Coalition** working groups in which RWIT was the only association to have an experienced driver at each and every meeting.


Today, several RWIT Board members in addition to driving are public speakers, consultants, appointed members and volunteers at various worker events and **State Freight Advisory Committees** that study truck parking in order to develop capacity solutions for drivers. In 2022, RWIT President Desiree Wood was appointed to the prestigious Transportation Research Board National Academies of Science, Engineering and Medicine - Freight Planning and Logistics Blue Ribbon Committee where she brings the truck drivers perspective to the table for consideration for urban planners and infrastructure data researchers.











### RWIT IN THE FILM INDUSTRY

In 2020, RWIT/TEAR President Desiree Wood became an expert witness for cases that affect women who work as truck drivers involving sexual assault, pregnancy discrimination and a consultant for television and motion picture productions. Her 1st expert witness case resulted in a landmark \$5 million settlement for the Plaintiff in Jane Doe v CRST in 2021.

Desiree acted as a consultant for the motion picture "Paradise Highway" released in the Summer of 2022, starring Academy Award Winning Actors Juliette Binoche and Morgan Freeman. Since 2013, Desiree worked with Screenwriter/Director Anna Gutto to develop the script, and provide ride-alongs for her and lead actress Juliette before teaching her to drive a commercial motor vehicle for the movie. During the filming, Desiree acted as a stunt driving double and provided insight into the trucking lifestyle for the character Sally. She also appears in the movie playing the character Patti. RWIT Member Dianne McNair-Smith also appears in the movie as the character Dolly. REAL Women in Trucking is credited in the movie which depicts the camaraderie between women truck drivers based on the actual conference call chat rooms once hosted by the RWIT organization prior to 2015.



#### **Truckers Emergency Assistance Responders, Inc.**

RWIT launched a 2nd organization in early 2020, Truckers Emergency Assistance Responders, Inc., a 501 (C)(3) charity was created to help truck drivers affected by carrier abandonment who have no resources to get home with their belongings and pets. TEAR distributed over 13,000 units of PPE care packages to truck drivers in the early months of the Pandemic and has helped nearly 200 commercial drivers with short-term assistance since they formed.

#### **RWIT Award Programs**

### RWIT AT THE WHITE HOUSE

In April 2022, RWIT President Desiree Wood was invited to the White House for the Biden-Harris
Trucking Action Plan event. This was followed by the first ever Day of Action to Address Sexual Violence in the Trucking Industry hosted by the Department of Labor Women's Bureau. This event kicked off a series of invitations to RWIT members to attend events and to speak on this subject matter both in Washington DC and virtually for the Cornell University ILR Worker Institute – Equity in Focus Summit and the International Labour Organization - Uniting to End Gender-Based Violence and Harassment in the Workplace Summit.
